## WOULD YOU MEET WITH US BEFORE? HOW WOULD WE COMMUNICATE?

We always meet in person or virtually (via FaceTime or Zoom) 1-2 times before your wedding day. Outside of these meetings, communication is primarily initiated through text messaging/phone calls/email. Whatever works best for you.

## HOW MANY IMAGES WILL I RECEIVE?

The number of photos taken depends on several different things - the number of guests, hours of coverage, hours of dancing, and so forth. You can expect to receive anywhere from 500-800+ edited images.

## ARE OUR DIGITAL FILES WATERMARKED?

They are not. Neither the high resolution images nor the images we post to social media bear any watermarks. We rely on our clients tagging us in all of the photos they post (\*wink wink\*).

## DO YOU EDIT ALL OF OUR PHOTOGRAPHS?

Yes, I edit ALL of the useable images from our sessions/weddings (it is assumed that if you choose me to be your photographer, you trust my judgement in picking the most flattering images from the thousands I will take). My clients will also receive ALL of these edited images because no one really wants the job of selecting only a fraction of all the gorgeous photos that will be taken! Pretty awesome, huh?

## DO WE GET THE COPYRIGHT OF THE IMAGES?

Copyright is something we get asked about often. Copyright simply means that I am the creator of the images, and I “own” the copyright. Selling or obtaining “the copyright” is not possible. BUT you will have the ability to print and share your images as much as you would like.

## WHAT IS THE “ONLINE GALLERY” YOU MENTION IN YOUR COLLECTIONS?

The online gallery, Pic-Time, is a very user-friendly system that houses all of your photos. You will be given a password protected gallery to view and download your images straight to your computer or device.

We utilize a completely different system to deliver our films. The software is called Vid-Flow, and it provides clients with an easy way to download their film onto their computer or external drive.

## WHERE DO YOU LIVE AND HOW FAR WILL YOU TRAVEL?

We live in the panhandle of Florida. We LOVE to travel + we are open to travel as far as we can to capture beautiful memories for our clients. Primarily, we work along the Florida/Alabama gulf coast and would consider this to be our “service region.” Pricing can be adjusted to accommodate needs outside of our service area. Please message us if you have further inquiries about pricing related to travel fees. We are definitely up for some adventure!

## ARE THERE ANY HIDDEN FEES WE SHOULD KNOW ABOUT?

Nope! We have wrapped a travel fee into all of our wedding collection options, so there are no additional fees for our clients.

## CAN WE MAKE PAYMENTS LEADING UP TO OUR WEDDING DAY?

YES. One thousand times, yes! I completely understand being on a budget and trying to make money stretch in what seems like a million different directions. Weddings are beautiful, but it can be overwhelming thinking about all of the different vendors you need for a wedding. I am super flexible about payments. You can pay as much or as little as you want each month. I have the capability to send invoices monthly for the amount you would like to pay. I want to make this as easy as possible. Want to make monthly payments? Just ask me, and I will gladly get it set up for you! All I do require is a 20% deposit to secure your date.

## WHAT IS YOUR PAYMENT SCHEDULE?

For weddings we require the 20% deposit to be paid on the day you book with us. The remainder of your collection balance must be paid in full ONE MONTH prior to your wedding date. I do work with my clients to set up monthly payment plans. For all other sessions, I require full payment on the day of the session. Images will not be released to the client until payment is received.

## *frequently asked questions*

### DO WE GET THE PRINT RELEASE OF THE IMAGES?

All of my clients receive a print release/copyright release with their photo packages. This print release will give you rights to print any and all images you desire!

### WILL WE GET THE RAW FILES FROM OUR WEDDING DAY?

No. Rest assured that I will not withhold a quality photo from you. Anything that you don't see is either a duplicate, blurry/poorly lit, or unflattering. I take great pride in showing you the best of the best! As for video, we also refrain from giving clients the raw footage.

### WHEN SHOULD WE BOOK YOU FOR OUR WEDDING?

Typically, I suggest booking with me AT LEAST 3 months in advance. I have had clients book 12 months in advance. It is important to not to wait until last minute to ensure we have availability. Another reason why I like our couples to book with me as soon as possible is because it gives us more time to sit down with them, get to know them better, discuss wants/desires for their wedding day, and discuss the plan of action for their big day. If you are wanting to book me 2 weeks prior to your wedding day you won't get the full experience, and I want you to have that personalized experience and feel connected to me as your photographer.

## WHAT KIND OF EQUIPMENT DO YOU USE?

Our main camera bodies are Sony A7III's and a Sony A6500. We use A LOT of equipment throughout the day. You can check out everything I use by going to [www.kit.co/cedarrelics](http://www.kit.co/cedarrelics).

## IF I NEED TO CANCEL MY WEDDING, IS THE RETAINER REFUNDABLE?

The retainer fee/deposit is non-refundable. I will most likely not be able to refill that date on short notice. I encourage you to make sure your date is 100% confirmed prior to booking with me.

## CAN YOU HOLD MY WEDDING DATE?

Absolutely! For a 20% retainer fee, I would be happy to hold a wedding date for you.

## CAN WE PAY YOU PART OF THE AMOUNT AFTER THE WEDDING?

Unfortunately, no. However, I do have a payment plan option to alleviate the stress of paying the full amount all at once. Don't hesitate to ask about a monthly/bi-weekly payment plan!

## CAN OUR FAMILY AND FRIENDS TAKE PICTURES WITH THEIR CAMERAS?

It is our job to meet your expectations. We will certainly not be telling any of your guests that they have to put their camera away...unless you desire us to do so. It has become very popular lately for couples to have “unplugged” ceremonies and from our experience, these tend to make for better photos (there aren’t phones everywhere). As far as before and after the ceremony, we are generally trying to stick to your timeline as closely as possible. We will gladly take photos with you and whoever you would like a photo with. However, when more cameras get involved, time can get away from us quickly.

## CAN WE REQUEST SPECIFIC PHOTOS WE WOULD LIKE, SUCH AS FAMILY PHOTOS?

Absolutely! We encourage (basically require lol) our clients to provide a photo list or even example photos of things they definitely want. Sharing a Pinterest board is a great way to show us some photos you would love to have.

## DO YOU OFFER A SECOND-SHOOTER OPTION?

We do not provide a second-shooter at this time. Rest assured knowing that photo opportunities will be discussed in our consultations with our brides leading up to the wedding day. We want to make sure every important moment is captured.

## WHAT CAN WE EXPECT FROM YOU ON OUR WEDDING DAY?

From our experience, we like to be involved and provide input on your wedding day timeline. Our motto is always "Be flexible so you don't get bent out of shape." However, we have learned a thing or two that can make both of our days go smoother. We have worked with all types of brides and personality types and are able to adapt to whatever the situation may be.

## HOW LONG DOES IT TAKE BEFORE WE RECEIVE OUR IMAGES/VIDEO?

We give our couples a delivery timeline of approximately 12-24 weeks for completion of images and 20-36 weeks for the release of their wedding film. For our bridal & engagement sessions, the turnaround can be anywhere from 2-4 weeks depending on the time of year and how booked we are at the time. With all sessions, you can typically expect to see some sneak peaks within one to two weeks!
